Letter of Appointment

Terms of Appointment

Expectation of the Board/ Committees and the Fiduciary duties

The Roles and functions are stated below:

- 1. You shall help in bringing an independent judgement to bear on the board's deliberations especially on issues of strategy, performance. Risk management, resources, key appointments and standards of conduct;
- 2. You shall bring an objective view in the evaluation of the performance of board and management;
- 3. You shall scrutinize the performance of management in meeting agreed goals and objectives and monitor the reporting of performance;
- 4. You shall satisfy themselves on the integrity of financial information and that financial controls and the systems of risk management are robust and defensible;
- 5. You shall safeguard the interests of all stakeholders, particularly the minority shareholders;
